The Yoga Shala will send a confirmation email upon receipt of cancellation email notice.
4. Release of Liability. The member acknowledges and agrees that the practice of yoga includes inherent risks and will therefore not hold their Yoga instructor or The Yoga Shala liable from any mishaps from their participation in Yoga class.
5. Modification. This Agreement may only be modified by the mutual written agreement of both parties hereto. No oral statement shall in any manner modify or otherwise affect the terms and conditions set forth herein.
